Defeating Ohio's Pro-Abortion Ballot Initiative Requires an "All-Hands-on-Deck" Effort, Starting with our Shepherds

The fall of Roe v. Wade was a tremendous victory but the battle for life is far from over. The proabortion lobby has adopted a new tactic: passing state constitutional amendments to enshrine abortion into law. These have proven a highly effective strategy. Since the Dobbs v. Jackson ruling, 3 states have passed amendments guaranteeing the so-called "right" to abortion through all 9 months of pregnancy. Emboldened by this success, activists recently launched a campaign to do the same here in Ohio.

Two pro-abortion groups, *Protect Choice Ohio* & *Ohioans for Reproductive Freedom* are working on a ballot initiative to amend our state constitution. They have pledged over 30 million dollars on advertising which will undoubtedly be designed to confuse voters. So, from now until July 5th proponents will canvas our state collecting the 413,000 signatures needed to place this on the November 2023 ballot. This means that on November 7th –*less than 8 months from now*–every Christian will answer the question, "Should mothers have the right to kill their unborn children?" All that is needed for this amendment to pass is 50% of the vote, plus 1 vote.

Our state constitution is the supreme law of Ohio. All other laws are upheld or struck down based on their constitutionality. It's nearly impossible to overstate the damage that will be caused if this amendment passes. A portion of the proposed amendment states:

"Every individual has a right to make and carry out one's own reproductive decisions, including but not limited to decisions on contraception, fertility treatment, continuing one's own pregnancy, miscarriage care, and abortion."

According to this language, any attempt by our legislature to protect the unborn and their young mothers will be characterized as a restriction of this "right" and thus unconstitutional. If passed, this amendment will nullify all of Ohio's existing laws protecting the unborn. Because the amendment

language states that "every individual" has a right to abortion rather than "every adult," this will effectively overturn Ohio's parental notification laws, further endangering minors by allowing predatory adults to cover up the consequences of their abuse.

But the amendment language isn't constrained to abortion alone. The term "one's own reproductive decisions" is incredibly broad and not limited to the enumerated issues within the text. This means that if passed our state would recognize a legal right for each individual—regardless of age—to make medical decisions having to do with their reproductive organs. The logical and legal outcome is clear: this will have direct implications for gender-dysphoric minors obtaining irreversible sex-altering therapies, medications, & surgeries, — and without parental knowledge or consent!

If there was ever a need for the prophetic voice of our pastors and priests, this is it. The wolf is at the door of our churches, and we are calling on every shepherd in Mercer County and throughout Ohio to fortify their flock with the truth and to expose this insidious ballot initiative from their pulpits for the evil that it is.

We want to help you do just that. Over the next 8 months we will be traveling to as many of Ohio's 88 counties as possible to encourage and support pastors, elders, and church leaders to faithfully respond to this current crisis. We have developed a unique training session, "Together for Life," designed to equip and support church leaders as they proclaim the dignity of human life and the hope of the gospel to an abortion infatuated culture. Participants will be briefed on the legal ramifications of a proabortion constitutional amendment and given the tools necessary to prepare their flocks to stand against this threat. These events may be hosted in churches or homes at no cost to the host.


