Miami University's Intent to Install Plan B Vending Machine: Miami University plans to install a vending machine which dispenses emergency contraception pills. If this happens, Miami University will be the first college in Ohio to dispense this pill, known as Plan B, or the "morning after pill." This machine will give students access at any time to Plan B. Students for Life of America started a petition against the vending machine in hopes the school will not install it. Miami University Students for Life states, "We do not take a stance on contraception; however, emergency contraception has the potential to end human life. According to the manufacturer, 'Plan B' may prohibit the implantation of an embryo into the uterine wall. Because human life begins at the moment of fertilization, and because this product can prevent a fertilized egg (human life) from implanting in the uterine wall, this product can effectively work to end an innocent human life in its earliest stages." It is unknown exactly when and where the vending machine will be installed at this time. Katie Alig, from Miami University, updated Mercer County Right to Life on what is going on and what we can do to help stop this evil:

"Hello! My name is Katie Alig, and I currently attend Miami University. I was born and raised in Coldwater, OH---you may know my parents Chuck and Lisa Alig---, so Mercer County has a special place in my heart, especially when it comes to its strong value of life.

I am writing to inform you of unfortunate news that Ohio may soon have its first 'Plan B vending machine' installed. I have been made aware that Miami University plans to install one come Fall 2023 semester, making the morning-after pill highly accessible to students. Not only will this affect Miami students, but it could signal the start of a Plan B movement on Ohio campuses---or even high schools---that I would not stop short to call a nightmare. Furthermore, I want to recognize that this vending machine may be placed merely an hour and a half from Mercer County---too close to home, in my opinion.

There is currently a petition being circulated against this plan to place a Plan B vending machine on Miami's campus. If you are willing and able, I kindly ask that Mercer County Right to Life sign it, as well as share it with members and their families. I have attached the link below.
